The reports generated from these discussions will contribute to the policymaking process. The inaugural meeting of the Group was hosted by ISID in a hybrid mode on June 20, 2024. Explaining the Conundrum of Service-led Growth in India: Changing Composition of Demand and Income Distribution

The study investigates a significant question regarding the structural changes India has undergone over the past few decades. India has experienced service-led growth with a relatively low share of manufacturing compared to advanced economies during their industrialisation. However, this trend of early service-led growth is not unique to India but appears to be a common feature among many developing countries in recent years. This study provides insights by empirically analysing trends and patterns in the consumption expenditure of the average Indian household over the past few decades, which may help explain the service-led growth. It also highlights how gaps in consumption expenditure across regions and consumption quartiles have narrowed over the years, while a large portion of average consumption expenditure is allocated to services. Meanwhile, the share of expenditure on durable and semi-durable goods remains very low. The study emphasises a shift in the boundaries between discretionary and non-discretionary expenditure over time, driven primarily by rising per capita income, changes in labour use and dietary habits, increased aspirations for upward mobility across classes, and a reduction in public provisioning of certain services, leading to higher private spending on medical services, education, and communication. Growth of Labour-Intensive Sectors in India (Textiles, Leather, Gems & Jewellery, and Food Processing)

The project, sponsored by NITI Aayog, is a policyoriented study aimed at assessing the challenges and opportunities of labour augmenting growth in labourintensive sectors in India. It addresses the broader issue of the persistent gap between economic growth and employment, which continues even during periods of high growth in India. The underlying concern of this project is to address the critical issue of slow employment growth in a country with abundant labour reserves and to propose recommendations for creating meaningful employment opportunities. The study focuses on four labour intensive sectors identified in the project's Terms of Reference: food processing, textile and garments, leather and footwear, and gems and jewellery. These sectors have relatively high labour-tocapital ratios and significant potential for generating new jobs. The research will utilise various secondary databases to examine the nature and growth of employment in these sectors, their export potential, extent of import dependence, and India's comparative advantages in the global market. In addition to analysing secondary data sources such as ASI, NSSO, PROWESS IQ, UN COMTRADE, and TIVA, the project will also gather insights through interactions with various stakeholders, including big and small manufacturers, exporters, industry associations, export councils, and policymakers via field visits and interviews. Professor T C A Anant joins ISID



Prof T C A Anant, former Chief Statistician of India and Secretary, Ministry of Statistics and Programme Implementation, Government of India, joined ISID as a Distinguished Visiting Professor in April 2024. Prof Anant had served as the Director of Delhi School of Economics and as the Member of the UPSC. He also served as Member-Secretary at ICSSR, New Delhi. His research interests include economic theory, industry, labour, and industrial statistics.

Landscape of Regional Manufacturing in India: Reflections from Commodity Flow Analysis

The project awarded by Northern Regional Centre of ICSSR, aims to analyse regional manufacturing in India at the district level using commodity flow data. Other objectives include examining manufacturing within districts along the Delhi-Mumbai Industrial Corridor (DMIC) and assessing the alignment of commodity flows with Special Economic Zones. Given the paucity of district-level manufacturing data, as the ASI does not provide district codes and the NSSO Unorganised Enterprise Survey is outdated (2015-16), efforts will be made to generate data from commodity flow information. Railways track the movement of freight by commodity, including district of origin (shipment) and destination (receipt). The study will utilise railway commodity flow data from the financial year 2022-23 and/or the previous year, such as 2012-13, if available. Attempts will also be made to obtain freight data from the Ministry of Road Transport or truck associations. Where possible, railway data will be combined with road data. Commencing on July 15, 2024, the project will span 12 months. Dr Surva Tewari is the Project Director of the study.
